## Cancelled Classes

Days that are cancelled due to inclement weather (snow, ice, etc.), or business needs, may be made up at the end of the school year when facility space and capacity allow. Credits will be issued only if more than six (6) days of a program are cancelled without make-up days scheduled. Example: If a student attends on MWF for the school year, and more than six (6) days are cancelled and cannot be made up, any additional days would be refunded to the payer.

PP&R classes, activities, rentals, and sports events may be canceled due to inclement weather, such as ice, snow, or extreme heat.
